The Caddo Parish Commission met in a Work Session, on the above date, at 3:30 p.m., via Zoom teleconference, with Mr. Johnson, presiding, and the following members in attendance constituting a quorum: Commissioners Atkins, Burrell, Cawthorne, Chavez, Epperson, Gage-Watts, Hopkins, Jackson, Johnson, Taliaferro, and Young (11). ABSENT: Commissioner Lazarus (1).

The invocation was given by Mr. Taliaferro, and Mr. Young led the Commission in the Pledge of Allegiance.

It was **moved by Mrs. Gage-Watts,** seconded by Mr. Cawthorne, *to approve consideration of items under La.R.S. 42:17.1.* Motion carried, as shown by the following roll call votes: AYES: Commissioners Atkins, Burrell, Cawthorne, Chavez, Gage-Watts, Hopkins, Jackson, Johnson, Taliaferro, and Young (10). It was **moved by Mr. Atkins,** seconded by Mr. Hopkins, that Ordinance No. 6112 of 2021, an ordinance amending the Budget of Estimated Revenues for the American Rescue Plan Fund to provide an appropriation for Caddo Parish Juvenile Court, and to otherwise provide with respect thereto be moved to Thursday's agenda for introduction.

Substitute motion by Mr. Johnson, seconded by Mr. Cawthorne, to englobo and move the following ordinances to Thursday's agenda for introduction:

It was **moved by Mr. Johnson**, seconded by Mrs. Gage-Watts, that Ordinance No. 6115 of 2021, an ordinance to enact Sections 32-115—32-118 of the Code of Ordinances of Caddo Parish relative to Curfews, to provide for a curfew for persons under 18 years of age, to provide for penalties for violation of said curfew, and to otherwise provide with respect thereto be moved to Thursday's agenda.

Mr. Hopkins wanted to know what the penalties are. Mr. Johnson said that the first offense is \$250 fine, and any offense after that would be up to \$500, and the curfew is set for 11:00 PM.

Mr. Chavez wanted to know where the juveniles will be held. Mr. Johnson said that the City normally takes them to the Rutherford House. If the Parish would like to take them there, then an agreement would need to be drafted.

Mr. Young wanted to know what happens to the parents if they cannot afford the fines. Mr. Johnson said that there are alternate scenarios, such as community service or jail time for the parents. Mr. Taliaferro wanted to know if there would be any provisions for the minors who are gainfully employed. Mr. Johnson said that is one of the exceptions.

At this time, Mr. Johnson's motion carried, as shown by the following roll call votes: AYES: Commissioners Atkins, Burrell, Cawthorne, Chavez, Epperson, Gage-Watts, Hopkins, Jackson, Johnson, Taliaferro, and Young (11). NAYS: None (0). ABSENT: Commissioner Lazarus (1). ABSTAIN: None (0).

It was **moved by Mr. Hopkins**, seconded by Mr. Atkins, that Resolution No. 69 of 2021, a resolution to provide an annual certification to the State of Louisiana Department of Transportation & Development in accordance with the Off-System Bridge Replacement Program, and to otherwise provide with respect thereto be moved to Thursday's agenda. Motion carried, as shown by the following roll call votes: AYES: Commissioners Atkins, Burrell, Cawthorne, Chavez, Epperson, Gage-Watts, Jackson, Johnson, Taliaferro, and Young (11).

It was **moved by Mr. Johnson**, seconded by Mr. Cawthorne, that Resolution No. 70 of 2021, a resolution urging and requesting law enforcement agencies with jurisdiction in Caddo Parish to enforce laws regarding teen curfews, including, but not limited to LA.R.S. 32:416.1, and otherwise providing with respect thereto be moved to Thursday's agenda.

Mr. Atkins asked for clarification for this resolution. Mr. Johnson explained that this is a state statute and prohibits juveniles from driving from 11:00 p.m. until 5:00 a.m. He also said that there are exceptions, such as employment, being in the car with an adult/guardian, etc.

Mr. Jackson wanted to know if this was a mandate or a requirement. Attorney Frazier said that this resolution is to encourage law enforcement to enforce the statute. She also explained that the officer has the discretion to whether or not they want to enforce it. Mr. Jackson wanted to know if this is in the name of public safety. Mr. Johnson said that it is.

Mr. Chavez requested that local law enforcement be present at Thursday's Regular Session to get their input on this resolution. Dr. Wilson said that they will attempt to ask any questions and inform the Commission. He also pointed out that there is a shortage with law enforcement officers, both with the Sheriff's Office and Shreveport Police Department.

Mr. Hopkins said that he supports both the ordinance and resolution, but would like to have a further discussion on where to bring the juveniles who are in violation. He gave an example of deputy picking up a juvenile in Ida or Keithville and bringing them all the way to Shreveport, especially since there is a shortage with the deputies right now.

Mr. Young agreed that every law that is passed can be phrased as a mandate. He also said that this resolution requests a high level of service, especially since the law enforcement offices are understaffed. He also suggested re-examining property taxes or increasing taxes to get those staff levels higher.

Mrs. Gage-Watts said that the public is begging for the Commission's help with regards to the recent events in the community. She further explained that this is asking law enforcement officers to enforce a law that is already on the books.

Mr. Epperson wanted to know if the City has a curfew law. Attorney Frazier said that they do. Mr. Epperson said that the majority of the juvenile problems are coming from the urban areas.

Mr. Johnson explained that he put this resolution on the agenda because there is already a driving curfew on the books, and this resolution is asking law enforcement to enforce this law.

ADMINISTRATION REPORT

U.S. Treasury Emergency Rental Assistance Program

Dr. Wilson said that 7,892 applicants have been served under this program. He also mentioned that there is no waiting period for any of the assistance, as long as all the documentation is completed properly. He also said that over \$15M have been dispensed through this program.

Dr. Wilson also said NACo mentioned that Caddo Parish is one of four counties to dispense over 90% of ERAP funds. Mr. Jackson pointed out that NACo is facilitating this, but it is the USDA who is one of the largest departments to administer housing and rental assistance.

Mr. Young commended Finance and Administration for their hard work on the ERAP program. Mr. Jackson agreed and applauded the collaborative efforts with Mrs. Barnett, Mrs. Bryant, and Dr. Wilson.

Juvenile Detention Center

Dr. Wilson said there are currently seventeen juveniles in the detention center, three of which are OJJ and six seventeen-year olds. There are also ten juveniles at Caddo Correctional Center.

August Financials

Dr. Wilson said that the August Financials are attached to the agenda, as well as a hard copy in each Commissioner's box.

COVID Cases

Dr. Wilson said there were no positive COVID cases in Administration. There were 3 positive cases and 3 exposures in Animal Services. There was 1 positive case in the Commission Clerk's Office. There were 8 positive cases and 1 exposure in Facilities & Maintenance, with 1 death. There were 2 positive cases and 1 exposure in Finance. There were no positive cases in HR. There were 3 positive cases and 4 exposures in Juvenile Services. There were no positive cases in Parks & Recreation. There were 3 positive cases and 4 exposures in Public Works. There were 2 exposures with the Summer Work Program.

COMMUNIQUES & COMMITTEE REPORTS

- Mr. Jackson wanted to know if there was a timeline to meet in person. Mr. Johnson said that it depends on the number of COVID cases. He said that there are still COVID cases in the organization. Mr. Jackson agreed on the safety aspects, but feels that it is hurting their ability to address some items on the agenda, especially those items with deadlines.
- Mr. Jackson then talked about today's Economic Development Committee meeting regarding the Amazon TIF. He said that there were very little questions regarding the TIF. He asked that the Commissioners work together and have discussions on all issues.

He also wanted to know if the information for the ARP has been submitted. Mrs. Bryant

said that the reporting requirement was adjusted due to the census, but that information has been provided to the U.S. Treasury. Mr. Jackson asked for a copy of this.

- Mr. Young also asked that the Commissioners to appoint a representative to the Juvenile Services Citizens Advisory Board. He also asked that the Commissioners review how to raise the Juvenile Services millage to provide more services to the juveniles.
- Mr. Cawthorne also congratulated the staff on the ERAP program. He would like to see this in as many periodicals as possible.

He also talked about the Economic Development Committee. He said that it was a productive conversation and many concerns and questions were answered to help move the process down the road.

- Mr. Atkins also talked about the Economic Development Committee. He said that it is important to get input from a number of people when working through an important decision.
- Mrs. Gage-Watts said that the recommended appointments for the Juvenile Justice Citizens Advisory Board are on hold due to the requirements of the teleconference agenda.

She also asked Mrs. Bryant how much would the millage need to be increased to bring the Parish up to date. Mrs. Bryant said there is a \$4M deficit in the Juvenile Services Fund. Ideally, they would like to pass a millage of 4 or 5 mills, but not more than 5 mills. She said that could bring in \$6M-\$7M. it would not eliminate the deficit, but would help out tremendously. Mrs. Gage-Watts wanted to know how much that would cost a citizen who has a \$200k home. Mrs. Bryant said that it would be approximately \$60 per year.
